Flexible Sigmoidoscopy

Preparation:

If you take medication, especially high blood pressure medication, you may have it on the morning of the procedure with a small sip of water. **STOP ASPIRIN and iron FOUR (4) days prior to your procedure date. Inform the nurse immediately if you are taking other blood thinners (such as Coumadin or Plavix).**

- The night prior to your examination take magnesium citrate at 6 p.m.
- The day of your exam take 2 fleets enemas 30 minutes apart prior to leaving your home.

PLEASE NOTE: IF YOU WILL BE HAVING THE PROCEDURE WITH SEDATION, A DRIVER MUST ACCOMPANY YOU: You will not be able to drive, use a taxi, or a bus after the procedure. Your driver must be on the premises during your procedure or the procedure will be rescheduled.

- If your procedure is in the morning you should have nothing to eat after midnight.
- If your procedure is in the afternoon do not eat after _____.
